

Declaration upon submission of an electronic academic thesis (dissertation, habilitation) at Ruhr University Bochum

1. Original

I hereby declare that the electronic version of my academic thesis submitted to the university library corresponds to the approved examination copy and formally complies with the provisions of the doctoral regulations / habilitation regulations.

The publication of the dissertation / habilitation thesis has been approved by the doctoral committee / habilitation committee.

Data formats, data carriers and additional data, as well as the number of copies submitted, comply with the doctoral regulations/habilitation regulations and the requirements of the university library. I have checked the submitted electronic academic thesis for completeness and legibility. I undertake to check the online publication for completeness and legibility after it has been processed and made available by the university library.

2. Online availability

Publication by the university library

I hereby irrevocably grant Ruhr University Bochum the non-exclusive (simple) right to reproduce the submitted electronic scientific thesis and the accompanying descriptive data (abstracts and metadata) on its own servers, to store it electronically for an unlimited period of time, to make it publicly available on international data networks and, if necessary, to convert it into another format.

Publication by a publisher (additional publication by the university library): I grant the university library permission to publish my electronic scientific thesis in addition to the publisher's publication.

3. Long-term archiving / conversion to other formats

I irrevocably grant Ruhr University Bochum the right to store the electronic scientific thesis in a long-term archive via the library. Furthermore, it is irrevocably granted the right to convert the electronic scientific thesis, abstracts and metadata into other electronic and physical formats as required (e.g. migration, accessibility, better accessibility, indexing) and to use them in accordance with No. 2, while ensuring that the content is preserved.

4. Transfer to libraries with a national collection mandate

Ruhr University Bochum is irrevocably entitled to transfer the academic thesis, including the associated metadata and abstracts, to the German National Library and other relevant subject-specific or regional document servers with the same rights as mentioned above.

5. Third-party rights

I confirm that the document does not violate any legal regulations, official orders or third-party rights. In particular, I confirm that I am the sole legal owner or have all necessary rights of use. This includes the images (photos, graphic elements) contained in this work. I am responsible for the content of the document to be published.

The publishing person indemnifies Ruhr University Bochum against any claims by third parties.
